The regular Town of Starkey Board meeting was called to order at 7:00 PM by George Lawson, Supervisor.

Pledge of Allegiance- George Lawson led the pledge of allegiance.

Approval of Minutes

Minutes of the March 9, 2023, regular meeting of the Town Board, were approved as written. A motion was made by Caryl Sutterby, councilperson, seconded by Julie Dunkelberger, councilperson. *All in favor: none opposed- Motion carried.

Board of Elections – Bob Brechko and Sheila Burt discussed changes to the election laws and processes.

Website

Candace set up a demonstration with CivicPlus, Julie, Caryl and George attended the demo following the last meeting. George recommended that we pursue using CivicPlus, as they work exclusively with municipal and governmental entities.

Summer Youth Employment Program

- George has contacted work force development seeking summer youth employment to work with the code office to scan property files.
- John has concerns, stating that there are firms that cost a lot of money, "why do we feel that a student would be able to do an adequate job?"

Speed Study

Jeff Tomion, of Fir Tree Point Rd, asked the board to do a speed study on Fir Tree Point Road, in hopes of lowering the speed to 30mph. He states that his front porch is 15 feet from the road, there are multiple rentals, and vehicles that are unfamiliar with the characteristics of the dead-end lake road makes a 55mph speed limit dangerous.

> Ralph Warren suggests that we request the same study for all the roads given the similar characteristics and concerns for residents and renters alike.

Code Enforcement Office Report—Brian Shriver

- Brian asked for an extension regarding Sean Socha's shed on Lakeview Road, that was built in 2022, following the Zoning Board of Appeals Area Variance approval in November 2021, that was then denied on March 16th, 2023. Local Law states that the violations must be remedied within 10- days, however this is impossible given the scope of the project.
- Code enforcement reports were received by the board. Caryl asked Brian to attend next month's meeting.

Supervisor Report— George Lawson

- The sealed bid opening for the Town Hall roof and masonry took place on March 30th, 2023, at 4:00PM, the

- Ralph presented 3 quotes for the replacement of the heating units at the Town Barn. George states that we need to confirm that the quotes include prevailing wage.
- Town Highway barn roof George and Ralph were on the roof, there are no noticeable causes of leaking, they feel
 that the nails could not be long enough, and that replacing them with longer screws and gaskets could remedy the
 issue.

Justice — Carrie Wood

Carrie reported that she received the grant that she applied for in the fall of 2022. Funds totaling \$17,413.75, for
