## **Approval of Minutes**

## Open Public Hearing for Proposed Resolution for an Aged Exemption LL-2-2023

The advertised public hearing to consider the adoption of the Local Law to Change income eligibility for the Aged
Tax Exemption was opened at 7:01 PM by George Lawson, Supervisor for discussion with the residents attending
this meeting.

## Code Enforcement Report— Brian Shriver

- Brian presented the Code Office progress report.
- Brain presented a new product to mark septic systems which can be detected by metal detectors and located with
  the use of GPS. Colby Peterson from Yates County Soil and Water is hoping to secure grant funding to help make
  this product available to Yates County townships and residents to make septic system location substantially easier.
- He is also hoping that a program through Yates County comes to fruition to define countywide standard operating
  procedures for code enforcement officials to make reporting more consistent, allow code enforcement officials to
  cover for one another in a health emergency, and to create a mentorship program for new code enforcement
  officials.

## **Close Public Hearing for Aged Exemption**

 George Lawson made a motion to close the public hearing for the proposed Local Law to change income eligibility for the Aged Tax Exemption. Was closed at 7:13 PM.

# Town Clerk Report --- Amy Fleet, Deputy Town Clerk

- The clerk's report was presented to the board.
- Amy stated that hunting license sales continue to be very steady.
- There was also a discussion about dog license sales and George wondered when the last survey was done to determine the number of unlicensed dogs in the Town of Starkey.

#### **Highway Report**— Ralph Warren

• The 284 forms for approval along with the quote for the second round of oil and stone have been signed for Stone Jug Road.

- Discussed Starkey Point with Soil and Water whether it was our responsibility or residents. To maintain road access
  to the public road on the bottom portion of the road we will need to assume responsibility for the culvert. Agreements
  will need to be made with the landowners and Yates County Soil and Water will need to engineer a plan for this
  project. George also asked if Ralph had looked into a pipe covered with a protective coating and what the cost
  difference might be? George also inquired if the County Highway department would be assisting with this project
  and Ralph said he did not think so.
- The mowing is also being caught back up.
- Ralph is working with Auctions International to list the Chevy Volt and the Dynaweld trailer.

## Supervisor Report— George Lawson

- Approved the rollover of 5 hours unused vacation time and 15 hours of sick time for Chelsea Chapel through a
  motion made by George Lawson, supervisor and seconded by Jeremy Hall.
- Budget Workshop is set for September 29<sup>th</sup> at 4 p.m.

#### **Generator Resolution**

• During the August meeting the board discussed the bids for a generator at the Town Highway Barn and during this meeting the resolution was adopted to move forward with the selected bid. Jeremy Hall Councilperson made a motion to approve the purchase of the generator and John Socha, council person seconded the motion. The Town does not plan to move forward with plans for a generator for the Town Hall at this time.

• The board discussed and George Lawson, supervisor made a motion to approve Theresa Grady's NYSLRS calendar to make her eligible for NYS retirement and Caryl Sutterby, councilperson, seconded the motion.

## Sign

- Amy presented the two designs Candace had received from Ian MacDonald of Historic Sign Restoration in Rochester as well as a 3- tiered pricing schedule.
- Jeremy Hall, councilperson made a motion to approve the \$3,827 option that has a 25-year lifespan which should result in less maintenance over the life of the sign and Caryl Sutterby, councilperson seconded the motion.

#### **Tablets**

 George said that the Planning Board discussed the purchasing of tablets to alleviate printing costs and the board members felt that they would not use the tablets and that they print off necessary paperwork for meetings at home prior to meetings.
